PURPOSE

The sponsors are pleased to offer artists who produce dog-related art the opportunity to exhibit their work in a show devoted exclusively to canine art. In addition, the competition will benefit The American Kennel Club Museum of The Dog as the Best of Show winner will be purchased by the Sponsors for \$1,250.00 and donated to The American Kennel Club Museum of The Dog in St. Louis, Missouri.

ELIGIBILITY

All artwork must include a dog or dogs in the subject matter. The competition is open to all artists 18 years of age or older. Works must be original and must have been executed solely by the person in whose name they have been submitted. All entered artwork must be **priced & for sale**.

SPECIFICATIONS - ALL ACCEPTED WORKS

Two-dimensional works **MUST BE** framed, matted and **READY FOR DISPLAY!** We recommend that Plexiglas be used on shipped works that require glazing.

Size limitations:

Two-dimensional works may not exceed 48 inches on horizontal line, including the frame.

Three-dimensional works may not exceed 50 pounds in weight and must fit through a standard 32" x 80" doorway.

Works shipped by carrier must be adequately packed in crates or packages suitable for return.

Any artwork not conforming to the accepted images, not fulfilling the above requirements or not being adequately presented may be eliminated from the show.

SALES

All work submitted must be priced and for sale. Every possible effort will be made to encourage sales. **A 30% commission will be taken on all sales.** No commission will be charged on purchased Best of Show award.

ENTRIES

DIGITAL PHOTO ENTRIES ONLY!

Entry Specifications

- 1. Entries shall be digital photos in the JPEG format with a minimum file size of 1 MB.**
- 2. Each artist may enter up to four (4) entries.**
- 3. If more than one piece is entered, all entries must be submitted on a single CD.**
- 4. The file name on the CD must be the title of the piece. Example – If the piece is titled “My Dog”, the file name on the CD should be “my dog.jpg”.**
- 5. The CD must be labeled with the artist’s name.**
- 6. Three-dimensional artworks may include up to three (3) views of each entry.**
- 7. The CD must be accompanied by the completed entry form and full payment.**
- 8. Any accepted artwork which differs greatly from the entry photo will be disqualified.**
- 9. Entry CDs become the property of the Show Sponsors and will not be returned.**

Preliminary judging will be done from the digital images on these entry CDs!

A NON-REFUNDABLE ENTRY FEE OF \$40.00 (in U.S. Funds) per artist for up to four (4) entries must accompany the entry form. Checks and money orders should be made payable to: Art Show at the Dog Show.

Late entries will not be accepted. All sections of the entry and notification card must be clearly filled in and accompany the submission. Artists should consider the commission percentage (30%) on sales when pricing their work. Information on these as to price, title, etc. is final and not subject to change. **All entered artwork must be priced and for sale!**

All accepted work must be received by February 26, 2010 *If accepted, you will receive shipping Instructions on where to ship your work*

PUBLICITY

Signature on the entry form grants the Sponsors the right to photograph exhibited works for publicity, educational and publications purposes.

The Sponsors will endeavor to produce a catalog of the exhibit.
